SUBJECT:	Education funding regulations for 2007-08

I am writing to inform you that the Grants for Student Needs (GSN) regulations for 2007-08 have now been released. These regulations give effect to the funding improvements described in the memorandum of March 19, **2007: B2 – Education Funding for 2007-08**. Through these regulations, the government is allocating a projected \$18.26B for elementary and secondary education in the 2007-08 school year.

The new funding regulations are:

- (1) Grants for Student Needs Legislative Grants for the 2007-08 School Board Fiscal Year
- (2) Calculation of Fees for Pupils for the 2007-08 School Board Fiscal Year
- (3) Calculation of Average Daily Enrolment for the 2007-08 School Board Fiscal Year

These regulations may be accessed through the Ministry's public website, <u>www.edu.gov.on.ca</u>, where the Ministry has also posted final versions of the education funding *Technical Paper*, 2007-08 and *School Board Funding Projections for the 2007–* 08 School Year.

The implementation of some funding commitments described in **2007: B2** has required technical amendments to the 2005-06 and 2006-07 GSN regulations and the 2006-07 *Calculation of Fees for Pupils* regulation. In addition, the following regulations have been revoked:

- Student Focused Funding Legislative Grants For The 2001-2002 School Board Fiscal Year O. Reg. 154/01
- Student Focused Funding Legislative Grants For The 2002-2003 School Board Fiscal Year O. Reg. 156/02

Estimates forms have been revised to reflect the release of the 2007-08 regulations and are available on EFIS. The due date for submission of school boards' Estimates for 2007-08 is June 29, 2007.

School boards should also note the following:

• To assist boards with their capital planning for Primary class size, the Ministry will provide an excel file to help boards calculate their revised PCS capital allocations

for 2006-07 to reflect the regulation amendment. This file will be sent to boards in the near future.

- The document, Special Education Funding Guidelines: Special Equipment Amount (SEA) and Special Incidence Portion (SIP) 2007-08, is now available through the Ministry's website and from the Ministry Regional Offices.
- The current year's version of the guidelines, Special Education Funding Guidelines: Special Equipment Amount (SEA) and Special Incidence Portion (SIP) 2006-07, has been amended to include a timetable relating to the determination of staff support in the calculation of SIP funding. This timetable, a requirement of the application process, was referred to throughout the body of the SIP guideline, and is now included in the Guidelines as Appendix C.

I also want to advise you of a correction to the French-language version of **2007: B2**. On page 6 of the French-language version of that memo, under the heading <u>Réduction</u> <u>de l'effectif des classes au primaire</u>, the first sentence should read, "Pour poursuivre les efforts en vue de réduire l'effectif des classes au primaire, le gouvernement affectera à cette fin, en 2007-2008, 100 millions de dollars et augmentera ainsi le Montant pour la réduction de l'effectif des classes au primaire (ECP) pour le porter à 745 \$ par élève au primaire." This correction has been made in the online French-language version of **2007: B2** on the Ministry's website.
