SUBJECT: Full Day Kindergarten Student Transportation

**Funding Adjustments** 

Further to Memorandum 2010:813, lam writing to provide information on the final funding adjustments from the Full Day Kindergarten (FOK) Transportation funding submissions.

It should be noted that a regulation is required to implement the initiatives and investments described herein.

The Ministry intends to seek approval for such a regulation shortly and will advise you if such a regulation is approved.

# FULL DAY KINDERGARTEN STUDENT TRANSPORTATION FUNDING IMPACT

The Ministry consulted with school boards and consortia on the potential financial impacts on student transportation due to FOK implementation in summer of 2010. Most consortia indicated utilizing excess capacity in the first year to accommodate these additional demands. In some cases, a small number of additional bus runs were added during the transition. We have also been advised that savings were realized where noon-hour bus runs were eliminated.

However, with the full implementation of FOK, some consortia indicated that there would be added financial pressures as there will be fewer opportunities to use existing excess capacity. The Ministry engaged Management Partnership Services Inc. (MPS) to assist in developing a methodology to identify the impact that FDK may have on transportation

requirements within a consortium, its member school boards, and the associated costs. The funding approach to support FOK transportation, including the requested data from consortia that will be required to determine any funding enhancements as well as the methodology for calculating these potential funding increases was outlined in Memorandum 2010:813 - Full Day Learning Student Transportation Funding Needs.

### DATA COLLECTION AND METHODOLOGY

Since not all boards require additional transportation funding to support FOK implementation, consortia were requested to first review existing routing and the extent to which JK and SK students can be accommodated on existing routes. Consortia that applied for funding were required to send their completed templates that clearly identifies the projected costs associated with full implementation, with sign-offs from the Director of Education from all member school boards, to the Ministry by May 31, 2011. Boards were cautioned that the Ministry reserved the right to audit data submitted in the templates. Ministry staff reviewed submitted data and followed up, if necessary, before calculating specific funding amounts.

The Ministry applied the Routing and Technology rating from the Effectiveness and Efficiency reviews obtained as of the 2010-11 school year based on the following scale:

Routing and Technology E&E Review Rating	Percentage Adjustment

Moderate-High	90%
Moderate	60%
Moderate - Low	30%
Low	0%

For those boards that participate in more than one consortium, the eligible amount from each consortia will be combined to determine the total board funding adjustment (see Appendix A).

## **COST ENHANCEMENT RESULTS**

As a result of FOK Transportation submissions and reviews to confirm the accuracy of submitted information, the Ministry will provide \$2.0 million to eligible boards over the course of the FOK implementation, starting in 2011-12. Please see Appendix A for board-by-board funding adjustments.

#### APPLICATION OF FOK TRANSPORTATION FUNDING

An in-year regulatory amendment will be made for school boards that qualify for FOK transportation funding. In 2011-12, a board will receive 20 per cent of its FOK transportation approved amount in their Transportation Grant. Subsequent adjustments will be aligned with the Ministry approved FOK phase in timeline.
