I am pleased to inform you that the 2011 Child Care Financial Statements and instructions detailing the changes for this cycle are now available through the ministry's extranet site at http://faab.edu.gov.on.ca.

Training

To assist you in preparing the Financial Statements, the changes between the 2012 Estimates submission and the 2011 Financial Statements submission were highlighted during the recently completed regional training sessions held in February 2012.

EFIS Submission

The Financial Statement forms are accessible through the ministry's extranet site at http://faab.edu.gov.on.ca. After you login, click on the Financial Statements link on the bottom right side of the home page under Child Care, then select 2011.

Submission of Financial Reports

From the active EFIS submission of the 2011 Financial Statements, CMSMs and DSSABs are required to submit two original signed copies (hardcopy) of the following documents by May 31, 2012:

- Title (Cover) Page;
- Schedule 3.1 (all 3 pages); and
- Completed Explanation Report on variances.

For purposes of the Explanation Report, please use the file naming convention as indicated in the file 'naming convention' posted on the Financial Analysis & Accountability Branch's reporting website as noted above.

In addition to these documents, CMSMs and DSSABs are also required to submit the following information by May 31, 2012:

• Audited Financial Statements (including the auditors report and the notes to the financial statements);

- Review engagement or audit engagement report for the child care program prepared in accordance with the ministry's modified accrual basis of accounting, unless this information is already included as part of the audited financial statements; and,
- A post audit management letter issued by the external auditors. If such a letter is not available, confirmation in writing for the reasons for its unavailability.

Funding Adjustments

Funding adjustments, both positive and negative, resulting from CMSM or DSSAB financial statements submissions will be recovered or paid to the CMSM or DSSAB through an adjustment to the regularly scheduled monthly cash flow. A positive funding adjustment will be added to a future cash flow payment and a funding recovery will be deducted from a future cash flow payment.

Late Filing

The financial statements are due to the ministry by May 31, 2012. In the event that the Financial Statements are filed after this date, the cash flow withholding provisions may be implemented to reduce the CMSMs and DSSABs regular cash flow consistent with the terms in the service contracts. Upon submission of the Financial Statements, the ministry will revert back to the normal monthly payment process and will include the total amount withheld up to that point in the monthly payment. We are also asking that you please advise your financial analyst should you be aware that you will not be able to meet the May 31st deadline for submission.
