## **Submission**

The Revised Estimates forms are accessible through the Ministry's extranet site at <a href="http://faab.edu.gov.on.ca">http://faab.edu.gov.on.ca</a>. After you login, go to the Child Care heading. Select the Revised Estimates link. Under the CMSM/DSSAB heading, click 2012/13 then click on EFIS. CMSMs and DSSABs are required to promote their submission to "Active" status by August 31, 2012.

From the active EFIS submission of the 2012 Revised Estimates, CMSMs and DSSABs are also required to submit ONE original hardcopy of the following:

- Signed Title Page;
- Signed Schedule 3.1 (all pages must be submitted); and,
- Completed explanation report.

DSSABs are also required to submit the following documentation to support the TWOMO allocation. It may be submitted in **either** electronic format or <u>ONE</u> hard-copy form:

- 1) Approved 2012 DSSAB budget (not applicable for CMSMs); and
- 2) Levy Apportionment details (not applicable for CMSMs).

## **Late Filing**

As noted above, the Revised Estimates are due to the Ministry by August 31, 2012.
