Applicability

As per the 2012/13 Child Care Business Practices Guidelines for First Nations & Transfer Payment Agencies, the 2012/13 Estimates must be completed by all First Nations that have an allocation equal to or greater than \$350,000. The amount of your 2012/13 allocation may be found in Schedule B of your 2012/13 Child Care Service Agreement.

For First Nations that receive a funding allocation of less than \$350,000, the requirement to submit an Estimates submission does not apply.

Submission

The Estimates forms are accessible through the Ministry's extranet site at http://faab.edu.gov.on.ca/CCEstimates.htm.

First Nations are required to promote their submission to "Active" status by June 29, 2012. From the active EFIS submission of the 2012/13 Estimates, First Nations are also required to submit two original signed copies (hardcopy) of the following:

- Title Page; and,
- Schedule 3.1

Late Filing

As outlined in the 2012-13 Child Care Business Practices Guidelines and Schedule C of your 2012/13 Child Care Service Agreement, the Estimates are due to the Ministry by June 29, 2012. In the event that the Estimates are filed after this date, cash flow penalties may be implemented to reduce the First Nation's regular cash flow. Upon submission of the Estimates, the Ministry will revert back to the normal monthly payment process and will include the total amount withheld up to that point in the monthly payment.
