

Working with Education Finance Information System (EFIS) and Ontario Child Care Management System (OCCMS)

Financial Submissions Tip Sheet

This tip sheet is an optional tool to assist CMSMs and DSSABs in completing their 2015 Financial submissions. We recognize that CMSMs and DSSABs may have alternative mechanisms in place that assist them in providing the information required in financial submissions. Schedule 1.1- Contractual Service Targets

The ministry advises that data elements outlined in Schedule 1.1 include targets to be achieved using the funding in the service agreement (Budget Schedule) which includes both provincial and municipal cost shares.

Targets should include children supported through:

- Provincial Funding
- Municipal Cost Share Requirement
- Mitigation Funding

Schedule 1.2- Schedule of Other Data Elements

The ministry advises that data elements should include all child care service data (data reported in Schedule 1.1 and 100% municipally funded service) to align with adjusted gross expenditures (which include all funding sources). By including a projection which aligns with actuals, it will reduce variance reporting between estimates and actuals. Data Element (Projections/Actuals) should include children supported through:

- Provincial Funding
- Municipal Cost Share Requirement
- Mitigation Funding
- 100% Municipal Funding (if applicable)
- Other sources of funding not outlined in the ministries service agreement
