We are pleased to provide you with your 2018-2019 Ontario Early Years Child and Family Centre (Child and Family Centre) Service Agreement Package.

We know that considerable work is underway as you continue to work towards finalizing your Child and Family Centre plans to submit to the ministry by September 29, 2017. Thank you for your ongoing commitment and partnership to transform Ontario's child and family programs, we look forward to reviewing your plans this Fall.

### **2018-2019 Service Agreement for Child and Family Centres**

As previously communicated and set out in the *2018 Ontario Early Years Child and Family Centres: Business Practices and Funding Guidelines for Service System Managers*, the service agreement:

- Sets out a two-year contract cycle to support continuity in planning and reduce administrative burden.
- Includes a minimum expenditure requirement for child care and early years planning and data analysis services; and a maximum allowable expenditure of 10% of a service system manager's total Child and Family Centre allocation for administration costs (see Budget Schedule).

- Includes the payment plan based on your annual allocation divided across 12 months, and details about reporting requirements within the two-year period (see Payment Schedule and Reporting Schedule).
- Requires service system managers for areas designated under the *French Language Services Act (FLSA)* to provide French-language child and family programs and services in accordance with the Act and as outlined in their service agreement. Service system managers that are not at full French Language Services capacity, are required to submit a French Language Services Plan in June 2018. Details regarding this process will be released in early 2018.

### **Due Date for Service Agreement**

Service agreements are due to the Ministry no later than **October 31, 2017** in order to issue payment in January 2018. Please note that late filing of service agreements may result in delays in payments being issued.

### **Upcoming Key Dates:**

- Submission of needs assessment summaries and initial plans for Ontario Early Years Child and Family Centres including information on program locations, new sites, and how the system will be transformed, enhanced, and expanded over the course of the year are due by **September 29, 2017**.
- Signed service agreements submitted to the ministry by **October 31 2017**.
- Details regarding the branding strategy, visual identity project as well as processes to ensure up to date program information will be released in **Fall 2017**.
- Responsibility for service system management of Ontario Early Years Child and Family Centres transferred to CMSMs and DSSABs on **January 1, 2018**.

## 2018 Interim Report

The Interim Report submission for 2018 is due on **August 31, 2018**. Service system managers will continue to submit financial reports in the Education Finance Information System (EFIS) 2.0. Further information about this submission will be provided in the summer 2018 through the Financial Accountability & Data Analysis Branch.
