SUBJECT: 2018 Preliminary Child Care Allocations

We are pleased to provide the 2018 preliminary child care allocations for Consolidated Municipal Service Managers (CMSMs) and District Social Services Administration Boards (DSSABs).

To support ongoing expansion, the government is investing approximately \$1.58 billion in child care in 2018 which includes:

- \$1.26 billion general child care funding including the ongoing year 1 Child Care Expansion Plan funding of \$200 million;
 - Details of year 2 Child Care Expansion Plan investments and targets will be shared in 2018.
- \$100 million Canada-Ontario Early Learning and Child Care (ELCC) Agreement funding;
- \$203 million ongoing Wage Enhancement/Home Child Care Enhancement Grant (HCCEG) funding; and,
- \$12.5 million for Fee Stabilization Support (January to March 2018).

The government announced an investment of up to \$70 million over the next two years (including capital investments) for The Journey Together: Ontario's Commitment to Reconciliation with Indigenous Peoples (The Journey Together) to increase the number of culturally relevant licensed child care spaces and child and family programs off-reserve for Indigenous children and families beginning in 2018.

NEW

A. Fee Stabilization Support

As announced on October 26th in memo EYCC11 - Child Care Funding Update, the Ministry of Education recognizes that increasing operating pressures may lead to increases in child care fees. To support improved wages for the licensed child care workforce, affordability for families, and to address potential fee increases, the ministry will provide CMSMs, DSSABs and First Nations \$12.7 million in incremental funding for the first quarter of 2018, to support licensed child care staff earning under \$14 an hour as of December 31, 2017.

Funding for Fee Stabilization Support has been allocated to CMSMs and DSSABs based on their proportionate share of the total 2017 wage enhancement allocations. There are no municipal cost sharing requirements associated with this investment and CMSMs and DSSABs are permitted to use up to 10 per cent of this allocation on administration. This funding is available to all licensed child care centres and agencies, regardless of auspice.

The objective of Fee Stabilization Support funding is to stabilize licensed child care fees in Ontario. Funding must be used to increase wages in licensed centres and licensed home child care agencies for staff earning less than \$14 per hour (excluding wage enhancement), as of December 31, 2017. Licensees receiving Fee Stabilization Support must demonstrate the percentage change in child care fee increases avoided in 2018, as compared to December 31, 2017.

B. The Journey Together: Ontario's Commitment to Reconciliation with Indigenous Peoples

Approved projects to increase the number of culturally relevant licensed child care and child and family programs off-reserve for Indigenous children and families will be included in the program description and budget schedules of your service agreement.

A separate memo will be sent to CMSMs and DSSABs that submitted a proposal communicating decisions regarding The Journey Together funding.

UPDATES

C. Prioritizing Not for Profit Operators

The For Profit Percentage Threshold is included in service agreements to maintain funding to for-profit entities at or below 2015 expenditure levels. This threshold is based on CMSMs and DSSABs expenditures on for-profit operators in 2015 and applies to all child care funding except Wage Enhancement and Fee Stabilization Support. The ministry recognizes that a number of communities in Ontario are served by for-profit child care operators and will continue to work with CMSMs and DSSABs through this transition to meet the thresholds. CMSMs and DSSABs may revise the threshold in their service agreement to reflect 2016 expenditure data by working with their ministry Early Years Advisor and Financial Analyst.

D. ELCC Carry Forward Provision

CMSMs and DSSABs have the ability to carry forward 10 per cent of the 2018 ELCC funding allocation to December 31, 2019.

E. Child Care Funding Formula

As part of our annual process, the ministry has updated the 2018 child care funding formula for the general allocation with revised data elements including the Ministry of Finance's population projections, Ontario Works Caseloads, and Low Income Cut-Off (LICO) data. Changes to LICO data (2006 to 2011 data) are now fully phased in.

F. Wage Enhancement/HCCEG

Salary Cap

To align with adjustments to the salary and wages of the school-based ECE grid according to 2014-17 central labour agreements and extensions, the current salary cap of \$26.68 will be increased in 2018 by approximately 1.5 per cent to **\$27.07** per hour. The daily fees cap for HCCEG will also increase in 2018 from \$266.80 to **\$270.70** per day for full HCCEG and from \$160.08 to **\$162.42** for partial HCCEG.

Centres and Agencies that Open in 2018

To support recruitment and the increase of eligible staff and home child care providers as a result of the Child Care Expansion Plan, ELCC and the Journey Together, centres and agencies that open in 2018 will be eligible for wage enhancement/HCCEG once they begin operations.

Application Forms

The ministry will not provide an updated application template this year as a result of limited changes to the program in 2018. CMSMs and DSSABs can continue to use the application form template shared in 2017. Please ensure the increases to the 2018 wage cap for eligibility and requirements outlined in the 2018 Child Care Service

Management and Funding Guideline are reflected in the application forms. As previously communicated, the ministry will no longer issue a reconciliation template.

2018 REPORTING REQUIREMENTS

2018 Estimates

CMSMs and DSSABs are required to submit 2018 Estimates submissions by **March 30, 2018** in EFIS 2.0. Further information about this submission will be available in January 2018.

Contractual Service Targets

2018 Service Agreements

Consistent with 2017, the ministry requires CMSMs and DSSABs to set contractual service targets for fee subsidy, Ontario Works and special needs resourcing.

Child care expansion plan funding of \$200 million and ELCC funding of \$100 million included in your 2018 service agreement is provided to sustain year one's committed targets (the total commitment agreed upon in your 2017 agreement). As a result, CMSMs and DSSABs are required to confirm their sustained targets for child care expansion and ELCC, as well as report information should funding allow for targets to be exceeded. Year two targets and allocations for the child care expansion plan will be announced in 2018.

2017 Service Agreement Amendments

CMSMs and DSSABs have the opportunity to revise the distribution of their ELCC and child care expansion targets from 2017 to 2018 if needed. Revised target information must be provided to the ministry by March 30th, 2018. Early Years Advisors will schedule meetings with CMSMs and DSSABs to discuss all targets.

Cash Flow in 2018

Monthly cash flow for operating funding will continue to be based on the 2017 Revised Estimates submission entitlement until 2018 signed service agreements and Estimates submissions are received.

Monthly cash flow will be updated to reflect your 2018 allocation once the signed 2018 service agreement and Estimates submission are received by the ministry.

The ministry will email a scanned signed copy or mail a hard copy of the completed agreement back to your CMSM and DSSAB for your records.

As in previous years, in areas designated under the *French Language Services Act* (FLSA), CMSMs and DSSABs must meet the FLSA requirements outlined in their service agreement. Where the CMSM or DSSAB is not at full capacity, it is required to submit a plan to the ministry to build capacity. The 2018 plans are due to the ministry by **June 29, 2018**.

Early Years Advisors and Financial Analysts are the ministry contacts for child care. Please direct any questions or concerns to your existing contacts at the ministry; the contact list is available on the [Financial Analysis and Accountability Branch website](#).

For further information on child care funding including Fee Stabilization Support funding and The Journey Together please refer to the 2018 Child Care Service Management and Funding Guideline included in this package. Regional meetings will be scheduled to review updates to the guideline.

Your ongoing partnership is critical in providing child care across the province. We look forward to our continued collaboration as we work to strengthen the early years and child care system for children and families in Ontario.

Appendix B: Communications Protocol Requirements

All public announcements regarding provincial and federal investments in Ontario's child care and early years system are potential joint communication opportunities for the provincial government, federal government, school boards, the Consolidated Municipal Service Manager/District Social Services Administration Board (CMSM/DSSAB), municipalities and community partners.

Public Communications

Municipalities, school boards, CMSMs and DSSABs, and community partners should not issue a news release or any other public communication directed at media regarding major child care and early years investments, without:

- i) First contacting the Ministry of Education through EYCCinvestments@ontario.ca about your plan to publicly communicate these major child care and early years investments; and
- ii) Publicly recognizing the Ministry of Education's role in providing funding; and
- iii) Inviting the Minister Responsible for Early Years and Child Care to attend any events related to your investment announcement.

The Ministry of Education may also choose to issue its own news release and/or hold events about investments in child care and early years projects, in addition to those prepared by municipalities, school boards, CMSMs and DSSABs, and community partners. The intent of this protocol is to promote the role of both the Ministry of Education and stakeholders in bringing new child care and early years projects to local communities.

Major Announcements and Events

Important: For all major child care investments the Minister Responsible for Early Years and Child Care must be invited as early as possible to the event. Invitations can be sent to EYCCinvestments@ontario.ca with a copy sent to your ministry Early Years Advisor/ Education Officer. Municipalities, school boards, CMSMs and DSSABs, and community partners will be notified at least four to six weeks in advance of their opening event as to the Minister's attendance. If the date of your event changes at any time after the Minister has received the invitation, please confirm the change at the email address above.

If the Minister Responsible for Early Years and Child Care is unavailable, the invitation may be shared with a government representative who will contact your municipality, school board, CMSM or DSSAB, or community partner to coordinate the details (e.g. joint announcement). Municipalities, school boards, CMSMs and DSSABs, and community partners are not expected to delay their announcements to accommodate the Minister or a Member of Provincial Parliament (MPP); the primary goal is to make sure that the Minister is aware of the announcement opportunity.

Other Events

For all other media-focused public communications opportunities, such as sod turnings for example, an invitation to your local event must be sent to the Minister Responsible for Early Years and Child Care by email (EYCCinvestments@ontario.ca) with at least three weeks' notice. Again, please send a copy to your ministry Early Years Advisor/ Education Officer. Please note that if the date of your event changes at any time after the Minister has received the invitation, please confirm the change at the email address above.

Municipalities, school boards, CMSMs and DSSABs, and community partners are not expected to delay these “other” events to accommodate the Minister. Only an invitation needs to be sent; a response is not mandatory to proceed.

This communications protocol does not replace our stakeholders’ existing partnerships with the Ministry of Education. Regional early years advisors and regional child care licensing staff should still be regarded as primary points of contact for events and should be given updates in accordance with existing processes.

Acknowledgement of Support

The support of the Government of Ontario must be acknowledged in media-focused communications of any kind, written or oral, relating to the expansion plan and The Journey Together. Similarly, CMSMs and DSSABs announcements related to funding received through the ELCC must clearly acknowledge that the contributions were made by the Province of Ontario and the Government of Canada. This acknowledgment could include but is not limited to, any report, announcement, speech, advertisement, publicity, promotional material, brochure, audio-visual material, web communications or any other public communications. For minor interactions on social media, or within social media such as Twitter, etc. where there is a tight restriction on content, municipalities, school boards, CMSMs and DSSABs, and community partners are not required to include government acknowledgement. In addition, when engaged in reactive communications (e.g., media calls) municipalities, school boards, CMSMs and DSSABs, and community partners do not have to acknowledge government funding; however, if possible, such an acknowledgement is appreciated.
