Program Service Agreement Package

I am pleased to provide you with the 2024-25 child care and/or child and family program service agreement package. This package includes:

- 2024-25 updated schedules to the service agreement for your First Nation or Transfer Payment Agency (Schedules B-F)
- 2024-25 Ontario Child Care and Child and Family Programs Business Practice, Service and Funding Guideline
- Other supporting documents (as applicable):
 - 2024-25 Health and Safety Funding Request Form
 - o Child and Family Program Serious Occurrence Report Form
 - Ontario Works Overview.

The 2024-25 Ontario Child Care and Child and Family Programs Business Practice, Service and Funding Guideline is available online at the Ministry of Education's website and a copy is also attached. Please refer to the applicable sections of the guideline for details on each of the specific funding lines noted in your 2024-25 Budget Schedule.

Ministry Updates

In 2024, the ministry is investing approximately \$48 million to support 95 First Nations and three transfer payment agencies. This includes approximately \$36 million for child care and \$12 million for child and family programs.

A. Funding Guideline

Any changes to the funding guideline can be found in the Highlight of Changes section of the 2024-25 Ontario Child Care and Child and Family Programs Business Practice, Service and Funding Guideline.

B. Five-Year Transfer Payment Agreement

First Nations and transfer payment agencies will be entering Year 4 of the five-year service agreement with the ministry which is set to expire on March 31, 2026. As a reminder, following signature in Year 1 (2021-22) of the agreement, **signed agreements are not required** for subsequent years (e.g., Years 2 to 5). The attached schedules (B-F) supersede the existing schedules. Please retain a copy of these updated schedules with your signed 2021-22 agreement.

C. Funding for Mental Health Initiatives

In 2024, the government will be entering Year 2 of the three-year allocation of a total of \$9 million in funding (\$3 million per year for three years) toward mental health supports for families and children. This funding has been proportionally allocated across the province for EarlyON centres and First Nations with child and family programs.

Please refer to the 2024-25 funding guideline for more information about how First Nations with Child and Family Programs may use this funding to build further capacity in the system for mental health initiatives and your updated Schedule D: Budget

D. Funding for Health and Safety

The ministry is inviting First Nation communities with licensed child care centres and home child care agencies to apply for Health and Safety funding for 2024-25. First Nation communities requiring additional funding to meet licensing requirements may apply through the Health and Safety funding process. Please refer to the funding guideline for more details. While applications will continue to be accepted throughout the fiscal year, First Nation partners are encouraged to submit their applications to the ministry as soon as possible.

E. Wage Enhancement Grant and Home Child Care Enhancement Grant Increase Effective January 1, 2024, the ministry increased the hourly wage maximum for Wage Enhancement Grant (WEG) and Home Child Care Enhancement Grant (HCCEG) to help close the gap between RECEs in the education sector and eligible RECEs in licensed child care settings. The new hourly wage maximum for WEG is \$30.59 per hour, for full HCCEG is \$305.90 per day and for partial HCCEG is \$183.54 per day. This increase also applies to child care staff working in First Nation communities.

2024-25 Cash Flow

Monthly cash flow in 2024-25 has initially been based on the 2023-24 budget schedules. Once the 2024-25 budget schedules are released to the First Nation or transfer payment agency and are processed by the ministry, monthly cash flow will be updated to reflect your 2024-25 allocations and will include any catch-up payment.
