SCHEDULE B

THIS AGREEMENT made in duplicate the ____ of April 2004.

BETWEEN : the Minister of Education

(the "Ministry")

AND : The (Name of board)

("the Board")

This agreement defines the terms and conditions of the funding provided to the Board through the Ministry of Finance's *Strengthening our Partnerships* initiative to assist school boards in implementing Public Sector Accounting Board (PSAB) recommendations for local governments as their financial reporting standard.

The Ministry and the Board agree that the funding is subject to the following terms and conditions:

- 1. The agreement shall be in effect from the 1st day of April, 2004 up to and including the 31st day of March 31 2006.
- 2. Funding amount listed in Schedule II for the Board will be provided to the Board upon the Ministry's receipt of a signed copy of this Agreement.
- 3. The Board agrees to use the funds solely for the purposes as set out in the attached Schedule I.
- 4. The Board agrees to submit a report to the Minister in its 2004-05 financial statements indicating the expenditure incurred by the Board in the period April 01, 2004 to August 31, 2005 for the purposes set out in Schedule I.
- 5. The Board agrees to repay any funds to the Ministry of Finance that are not dispersed in accordance with the purposes set out in Schedule I.
- 6. As part of its training plan, the Board will:
 - a. participate in the PSAB training sessions provided by the Ontario Association of School Business Officials (OASBO) and the Ministry
 - b. identify training needs under this initiative for administrative staff at the Board and staff at the schools
 - c. make all reasonable effort to meet the training needs of Board staff.

- 7. The Board acknowledges that the PSAB implementation project is the responsibility of the Ministry and that the Ministry of Finance is providing funding only in order to assist with training and other related costs.
- 8. The Board shall keep and maintain proper financial records and books of account relating to the Initiative and shall make them available for inspection and audit at the Ministry's request. The Board shall furnish forthwith all information that may be required by the Ministry at any time with respect to the Initiative.
- 9. The Board and the Ministry warrant that they have read this Agreement including the attached Schedule I, understand and agree to be bound by it.
- 10. This Agreement, including Schedule I and Schedule II, constitutes the entire agreement between the parties.
