I would like to bring to your attention concurrent consultations that are currently being conducted by the Ministry of Municipal Affairs and Housing (MMAH) related to the land use planning and appeal system and the *Development Charges Act, 1997*. We are notifying school boards of these consultations as their outcomes could affect the planning and construction of schools. The registration deadline for the first public information session is <u>November 4, 2013</u>.

The MMAH is seeking public comment on making the land use planning and appeal system and the development charges system more effective to ensure they support local and provincial objectives while securing sustainable financing for new development. The goal is to ensure the systems are predictable, transparent, cost-effective, and responsive to the changing needs of communities.
