## Late submissions

It is important that school authorities meet the due date above since this information is needed for the interim reporting in the provincial budget.

Cash flow penalties may be implemented and the school authority's regular cash flow may be reduced by 50% where a board has not submitted its Financial Statements by December 31, 2014. Upon submission of the Financial Statements, the Ministry will revert back to the normal monthly payment process and will include in the monthly payment the total amount withheld up to that point.
