SUBJECT: Student Transportation – Grants for Student Needs,
2015-16

As a follow-up to Memorandum 2015: B07, dated March 26, 2015, I am writing to outline the transportation funding allocations through the Grants for Student Needs (GSN) in 2015-16. The total Student Transportation Grant is projected to be \$887.7M in 2015-16. A board-by-board summary of the projected allocations for 2015-16 is provided in Appendix A.

A. Transportation Funding Allocations

1. Enrolment Adjustment

The Ministry will continue to hold school boards harmless for declining enrolment. To maintain transportation service levels and meet pressures that may emerge from school consolidations, boards with declining enrolment will not see any negative adjustments made to their transportation funding. The Ministry will provide \$3.6M to support school boards with increasing enrolment.

2. Cost Update Adjustment

The Ministry will provide a 2 percent funding increase to support the provision of transportation services. Boards with a transportation deficit in the 2015-16 school year will receive the cost update adjustment, while boards with a transportation surplus will only receive the difference between their surplus and the cost update adjustment if the

surplus is less than the total value of the adjustment. It is estimated that \$10.7M will be provided for cost updates in 2015-16 school year.

3. Fuel Escalator and De-escalator Component

The Ministry recognizes that fuel costs for student transportation are beyond the control of boards and operators. School boards have been protected from fuel price fluctuations through the fuel escalation and de-escalation mechanism introduced in the GSN in 2010-11. For 2015-16, including the 2 percent fuel efficiency assumed, the Ministry will use the adjusted pegged retail price of \$0.936 cents per litre for southern school boards and \$0.957 for northern school boards¹.

The GSN regulation will continue to have a corridor of 3 percent above and below the adjusted funding pegged prices. If fuel prices, as posted on the Ministry of Energy website² (net of HST), are above or below this corridor in any month within the fiscal year, from September to June, a funding adjustment will apply. This provision takes into consideration frequent minor fluctuations in market fuel prices that are manageable within the industry and as such, monthly fluctuations in fuel prices within the corridor will not trigger any adjustments. The net total of the monthly funding adjustments will be applied to a board's transportation allocation following the submission of Boards' Financial Statement in December 2016. Boards should note that this adjustment could be positive or negative.

The Ministry would like to remind boards to take the potential funding changes due to fuel escalation or de-escalation into consideration when preparing their 2015-16 transportation budgets.

4. Transportation to Provincial and Demonstration Schools

Transportation for residential students attending English-language Provincial and Demonstration Schools will be coordinated by the Ministry's Provincial Schools Branch beginning in the 2015-16 school year. The lead board model will continue for French-language students attending Centre Jules-Léger with the Consortium de transport scolaire d'Ottawa. There are no changes to daily transportation to Provincial and Demonstration Schools.

5. Follow-up Effectiveness and Efficiency Reviews

The Ministry is committed to continuous improvement and will conduct follow-up reviews for the final year in 2015-16. Consortia must make a formal request to be considered for a follow-up review and provide information that demonstrates they have made significant progress since the initial review.

Consortia requesting a follow-up review are asked to complete and submit the attached form to the Ministry by June 30, 2015. Subject to the Ministry's review of the information

provided and confidence that the consortium has demonstrated they are operating at a highly effective and efficient level, a second review will be scheduled.

The review methodology and criteria are consistent with the original review. The reviews, however, have an additional focus on the implementation of recommendations and progress since the initial review. The Ministry will recommend further funding adjustments if the findings of the return visit support a higher overall rating than the previous review.

Upon receiving and reviewing the requests, the Ministry will schedule follow-up reviews based on the timing of the request, the number of requests received, and the availability of the E&E Review Team, subject to available funding. Note that availability is limited and priority will be given to consortia that demonstrate significant progress since their original review.

An estimated \$6.3M was included in OCDSB's projected 2014-15 allocation.
