SUBJECT:	Green Energy Act (GEA) Reporting, Webinar Training on How to Use the Utility Consumption Database (UCD) to Meet the Requirement, and Related Deadlines

This year will be the third year that the *Green Energy Act's* O. Reg. 397-11 requires Broader Public Sector (BPS) organizations, such as school boards, to submit an Annual Energy Consumption and Greenhouse Gas Emissions Report to the Ministry of Energy.

The Utility Consumption Database (UCD) allows all school boards to automatically compile the consumption data for all electricity and natural gas meters, significantly reducing the administrative burden of meeting the regulatory requirement.

To assist boards in preparing this year's report, the UCD provider, Aegent Energy Advisors Inc. (Aegent), will hold three webinars to refresh users on how to use the UCD to complete the Annual Energy Consumption and Greenhouse Gas Emissions Report.

Deadline for boards with an LDC that does not provide electronic consumption data for accounts through the EBT Hub to provide Aegent with a photocopy of a complete bill for all applicable meter numbers

Anticipated Timeframe to Upload Data to UCD: four (4) weeks

May 22, 2015

Deadline for boards to submit a photocopy of a complete bill to Aegent for the following meters:

- new meters
- meters with significant gaps in data
 - o more than 30 days

Anticipated Timeframe to Upload Data to UCD: three (3) weeks

Deadline for boards to submit their completed Alternative Utilities template for all FY 2014 accounts to their FTP folder

Anticipated Timeframe to Upload Data to UCD: two (2) weeks

July 1, 2015

Deadline for boards to submit their completed Annual Energy Consumption and Greenhouse Gas Emissions Report to the Ministry of Energy's online portal
