SUBJECT: **Funding in 2017-18 to Support the Implementation of 2017-2019 Labour Agreements**

The purpose of this memo is to provide school boards with information on funding changes occurring in the 2017-18 school year to support the implementation of the first year of the 2017-2019 labour agreements and to provide assistance on how these funds relate to the central agreements.

Some of the elements and proposals set out in this memo can only take effect if certain regulations are made by the Lieutenant Governor in Council under the Education Act. Such regulations have not yet been made. Therefore the content of this memo should be considered to be subject to such regulations, if and when made.

The majority of the funding being provided to support the implementation of the 2017-2019 labour agreements is through the Grants for Student Needs (GSN). There is also some funding that will be provided outside of the GSN through Education Programs – Other (EPO) transfer payments.

COMPENSATION

Further details on GSN funding to support compensation increases can be found in *Memorandum 2017:B04, Grants for Student Needs for 2017-18*.

BENEFITS TRUSTS

Additional funding to support benefits transformation is being provided through the GSN. Individual letters have already been sent to school boards to provide details on the funding calculation to support the costs related to the benefits trusts for 2017-18.

LOCAL PRIORITY FUNDS

System investments are being provided through the GSN unless otherwise noted below. The GSN memo (2017:B04) provided the total local priority funds. The purpose of this memo is to break down that funding for the groups where it is dedicated to specific federations and unions and how much is for non-union and other purposes.

Appendix 1 shows the amount for each school board broken out by central employee bargaining group. For each of the following groups, please refer to the priorities and uses outlined in their central agreement:

- Elementary Teachers' Federation of Ontario (ETFO)
- Elementary Teachers' Federation of Ontario - Education Workers (ETFO-EW)
- Ontario Secondary Schools Teachers' Federation (OSSTF)
- Ontario Secondary Schools Teachers' Federation – Education Workers (OSSTF-EW)
- Canadian Union of Public Employees (CUPE)
- Education Workers' Alliance of Ontario (EWAO)
- Ontario Council of Educational Workers (OCEW)

For L'Association des enseignantes et des enseignants franco-ontariens (AEFO) the funding is being made available for local priority investments designed to enhance student achievement and well-being in the classroom via additional AEFO teacher positions. Local consultations are expected to take place with AEFO representatives. For further information, please consult your trustee or school board association.

In the case of Ontario English Catholic Teachers' Association (OECTA), the figures found in Appendix 1 represents the projected funding amounts that was used to generate the FTE teachers shown in the OECTA agreement. This funding is being made available to hire the identified full-time equivalency (FTE) of elementary and secondary teachers as specified in the OECTA agreement in accordance with the process identified in the agreement. The *Others* column in Appendix 1 is primarily a provision for staff that are represented by other unions or are non-unionized. Boards have discretion over the use of these funds but are subject to any agreements boards may have with other union groups on the use of these funds.

COMMUNITY USE OF SCHOOLS (CUS)

As noted in Memorandum 2017:B04, Grants for Student Needs for 2017-18, an investment has been made in the GSN by increasing the amount for CUS in the GSN by 3% for the 2017-18 school year. Some of the agreements provide direction on the specific use of these funds. Where a board has agreements with its employees that specify the use of these funds, boards

should use these funds in accordance with the agreements. Of the nine central tables, only the CUPE, EWAO and OSSTF-EW agreements have a clause on CUS. If boards have agreements with staff represented by unions that are not part of the central tables, and these agreements have provisions on an increase to the CUS funding, then boards are expected to use this funding accordingly.

Where a board does not have any agreements specifying the use of this additional CUS funding, it is intended to support the general use of CUS funding, namely to reduce the rates for school space used by the community by helping boards with the costs involved with keeping schools open after hours such as heating, lighting, and cleaning.

For greater clarity, the attached table (See Appendix 2) shows the amount for each school board broken out for the three central tables identified above and other amounts.

AEFO INVESTMENT IN SPECIAL EDUCATION

Funding for French-language school boards to support the \$5M investment in 2017-18 in special education consistent with the AEFO agreement will be provided through an Education Programs – Other (EPO) grant. Further details on this EPO funding will be provided at a later date.

PROFESSIONAL DEVELOPMENT / LEARNING

The ETFO-EW and OSSTF-EW agreements specified the creation of a one-time Education Programs – Other (EPO) grant in 2017-18 for the purposes of professional development. The amount of the grant to each school board and the use of these funds can be found in the relevant agreements. Further details on this EPO funding will be provided at a later date.

CLASS SIZE INVESTMENT

As noted in *Memorandum 2017:B04, Grants for Student Needs for 2017-18*, an investment is being made in reducing class sizes in FDK and Grades 4 to 8. Please refer to 2017:B04 for details on the FDK investment. The following provides some additional details on class sizes for Grades 4 to 8.

Appendix 3 specifies the new regulated average class size (ACS) for boards that currently have a regulated ACS at or below 24.5. These boards will not be affected by this change.

Appendix 4 specifies the new regulated ACS for boards that currently have a regulated ACS exceeding 24.5. These boards will see a reduction in their regulated ACS such that they reach 24.5 within five years. This reduction has been calculated by determining the reduction in the regulated ACS that would be equivalent to the reduction in the funded ACS, taking into account that the number of additional classes resulting from a reduction in class size varies depending on the starting class size. Boards shall use the additional funding provided in 2017-18 to reduce their maximum class size average to achieve the new regulated ACS for 2017-18.

HUMAN RESOURCE TRANSITION SUPPLEMENT

To assist school boards with implementing the recently negotiated agreements, the ministry is providing a temporary transitional supplement of \$10 million. Each board's portion of the \$10 million was derived based on the board's share of the provincial total number of full-time equivalent education sector workers (includes teachers, principals and vice-principals, and other education workers) adjusted to exclude trustees and lunchroom supervisors (using data from the 2016-17 Estimates). Each board's amounts are available through the Education Finance Information System (EFIS) 2017-18 Estimates forms.
