Subject	Ontario Builds Signage for Capital Projects	

I am writing to inform you of our revised communications protocol as it relates to signage to assist in the Government's effort to promote important capital investments being made in Ontario's publicly funded education and early years systems.

Recently, the government introduced Ontario Builds - a new visual identity for all government infrastructure projects. Going forward, all major capital projects funded by the Ministry of Education will be required to display Ontario Builds signage at the site of construction for new schools, school additions, child care centres and EarlyON Child and Family Centres. This requirement also applies to Capital Priorities projects already announced in the 2019-20 and 2020-21 rounds.

All expenses related to Ontario Builds signage, such as design, production, and installation will be the responsibility of the school board. School boards will also be responsible for posting the signs in a prominent, high-traffic location in a timely manner.

To support boards in efficiently producing new Ontario Builds signs, please use the Ontario

Builds Visual Identity Guide and sign templates which are found at <u>https://www.ontario.ca/page/ontario-builds-templates</u>.

Here is an example of what a school board sign would look like:



School boards are to determine the best material for their projects. For reference, previous signage measured 8 feet x 4 feet and were made from 13oz vinyl mesh fabric that was weather resistant. Features such as grommets around the perimeter of a sign may assist in installation.

Please note that all signage must be approved by the ministry prior to production. Following production, boards are asked to confirm that signage has been installed by sending a photograph to the Ministry.
