Subject:	Updates to 2023-24 Student Transportation Grant	

I am writing to provide you with details regarding additional funding being allocated for the 2023-24 Student Transportation Grant for the following costs:

- Recruitment and Retention Bonus (R&R Bonus) for Contracted Special Purpose Vehicles
- Non-refundable Harmonized Sales Tax (HST) related to R&R Bonus
- School Bus Rider Safety Training Rate

Recruitment and Retention Bonus for Contracted Special Purpose Vehicles

The R&R Bonus (previously known as the School Bus Driver Retention Pilot Program - DRP) is intended to support the retention and recruitment of school bus drivers across the province. The eligibility criteria for R&R bonus in 2023-24 school year remains similar to the DRP that was in place for 2022-23 school year.

As stated in memorandum 2023: SB07, the Spare Driver Category includes provision for the R&R Bonus for an additional 5% of school bus routes, which may be used to pay for the R&R Bonus for contracted special purpose vehicle drivers.

For school boards where the number of contracted special purpose vehicle routes exceed 5% of school bus routes, additional funding is allocated to ensure that the boards can cover the cost of providing R&R bonus to contracted special purpose vehicles.

Based on routing statistics used in the 2023-24 Student Transportation Grant, this approach is projected to provide additional funding of \$4,259,880. Funding amount for each school board is presented in Table 1 of this memorandum.

As noted in memorandum 2023:SB07, school boards and consortia are not expected to administer or issue the payments to drivers; rather, they are expected to flow the funds to operators who are in the best position to administer these payments as they employ drivers of school buses and contracted special purpose vehicles used for student transportation.

School bus operators will flow the \$2,000 R&R Bonus to eligible drivers based on the criteria used in the previous DRP – such as holding an eligible drivers' license, having primary responsibility of employment as a driver for student transportation, and having a minimum attendance of 95% during the term.

Consistent with enhanced reporting, school boards or consortia and school bus operators will report the actual expenditures on the R&R Bonus for contracted special purpose vehicle routes along with school bus routes in the templates referenced in memorandum <u>2023:SB07</u>.

The year-end report from school bus operators for 2023-24 school year is to be submitted to the respective consortium by October 31, 2024. School boards and consortia are required to submit the 2023-24 school year reports on consortium and school bus operator expenditures to the ministry for their respective organization by November 30, 2024.

Non-refundable Harmonized Sales Tax related to R&R Bonus

School boards and the student transportation consortia are subject to 13% HST on the R&R Bonus paid to bus operators, of which 10.84% is covered from a federal rebate for non-profit organizations. To offset the cost associated with remaining portion of HST (2.16%) that is nonrefundable, the ministry is providing \$942,883 (based on applying 2.16% to \$2,363 which is equal to \$51 per eligible route) starting with the 2023-24 school year. Funding amount for each school board is presented in Table 1 of this memorandum.

The R&R funding for 2023-24 Student Transportation Grant is now projected to be \$43M and includes \$32M as noted in memorandum 2023: B06, \$6M to reflect the operator related payroll costs announced in 2023:SB07, \$4M for R&R Bonus of contracted special purpose vehicles and \$0.9M to the reflect the non-refundable HST for R&R Bonus.

School Bus Rider Safety Training Rate

The School Bus Safety Training Allocation provides funding for school boards that access standardized school bus rider safety training through a contract established by the Ontario Education Collaborative Marketplace (OECM).

Effective June 2022, OECM's contracted rate with Intertrain (vendor) has increased for on-site training from \$370 to \$420 per session, while the rate of online training remains unchanged.

The ministry is increasing the reimbursement rate from \$370 to \$420 per on-site session for the 2023-24 school year to align with the revised contract rate, so that school boards who plan to fully utilize the training funding would not incur pressures.

Conclusion
